- ◆ Minimum of 2 entries to constitute a class. Management reserves the right to add, cancel, split, or combine classes.

Directions to LCEC

From Columbia:

I-20 East to I-77 North towards Charlotte. Take exit 22, (Killian Rd.), right off exit ramp. At the intersection of the CVS, make a left onto Longtown Rd. Continue 1.5 miles into Long Creek Plantation. At the 4 way stop make a right onto Longtown Rd East. LCEC is one mile on the right, immediately after the dam. Follow signs to stable.

From Camden:

I-20 West to exit 80, (Clemson Road). Clemson turns into Killian Rd. Continue on Killian Rd. Make a right onto Longtown Rd. and follow the above directions!
